 - Response: In general, yes. There are no formal activities in place currently, but parents are encouraged to work with Ms. Karen Holt and classroom teachers to share their talents and time with the children.
 - Parent Question: Approximately how many hours of screen time per week or month are children exposed to?
 - Response: The state mandated limit is one hour per day.
 - Parent Suggestion: Create an Amazon Wishlist for school supplies, etc. that parents could contribute to in order to help offset operating costs for teachers and the school.
 - Parent Question: Is it possible for parents to make tax deductible donations to SFEI?

State of the School

Child Care Licensing

- SFEI cited for 2 serious deficiencies for teacher whose actions caused an injury to a child on 6.13.23. Teacher was terminated. Child recovered and returned to SFEI.
- All SFEI staff were counseled and completed refresher training in Positive Discipline and Guidance, Child Safety, Developmentally Appropriate Behavior, Classroom Management, and Maltreatment Prevention
- Professional childcare consultant Ann McKittrick and JSC counselors joined staff meetings to discuss stress reduction and managing emotional and physical health.
- SFEI directors are performing in person and video camera observations of all classrooms and following up with classroom management support highlighting appropriate redirection practices and seeing behavior as communication.
- Additional substitute teachers have been hired for support.
- Child Care Licensing increasing unannounced inspections for next 2 years.

 - Sanitation in main kitchen and classrooms
 - Children's Health Records, Children's Enrollment Records, Employee Training Files, Employee Background Checks, and Safety Drill Records examined
 - All staff is current on state childcare requirements:
 - Annual Pediatric CPR/First Aid
 - Annual 24 hours continuing education training topics: supervision, discipline, allergies, SIDS, emergency procedures, Infection Control
 - 5 Injury Self Reports (required medical attention). No Deficiencies noted

- Budgeted to use \$155,401 Child Care Relief Fund grant to cover loss
 - Needed \$126,481
- Enrollment is back to pre-pandemic levels
 - Increased staff salaries and increased kitchen costs continue to run the center in the negative
 - Liability insurance is much higher than budgeted
- Net Income Loss covered by CCRF grant
 - But will need to continue to gradually raise tuition to match current expenses before CCRF runs out
 - Board will strive to keep tuition below comparable schools

- Q1: Room for Improvement: Weekly Lesson Plans: Additional training and collaboration between Teachers, Curriculum Coordinator, and Directors resulting in consistent communication to parents of weekly lesson plans and center news through the Brightwheel App as well as continued posting of plans at the classroom doors.
- Q1: Room for Improvement: Food menu and quality: Added fresh mango, Mandarin oranges, sunflower butter, homemade mac and cheese, homemade pizzas, yogurt smoothies. Open action item to visit other stores with pickup option and look for more organic produce and additional protein items with less preservatives.
- **Q2: Number one in importance to parents is Safety:** In current SAA renewal negotiations, SFEI is requesting additional mowing of playgrounds to reduce pests. Reviewed classroom and playground safety procedures, updated Emergency Action Plans, practiced safety plans.
- Q2: Number two in importance to parents is Education: Resumed Spanish language classes and Music Movement classes. Continued success with Frog Street curriculum in meeting academic as well as social emotional learning needs.



- Q3: Best qualities of SFEI: The Stars of SFEI!!: Our teachers and support staff are valued and respected as loving Early Childhood Professionals. We all have a passion for working with young children, a desire to do something meaningful, a high level of energy, a joyful positive attitude, and a commitment to safety. We engage in opportunities to collaborate and learn in monthly meetings and outside training events. We reward teachers with year end performance bonuses, additional PTO for years 5+ of service, gifts for SFEI anniversaries, and gift cards for special recognition.
- Q3: Best qualities of SFEI: Activities: We love a theme week!! Continued focus on child-centered activities within traditional preschool themes. Enjoy field trips and enrichment activities. Added new activities for younger children to participate in fun days as well.
- Q3: Best qualities of SFEI: Parent Participation: Fun family social gatherings and events, unique experiences as part of the JSC family.
- Q4: Room for improvement: Screen time: SFEI subscribed to premium family plan for commercial free access to educational programs on YouTube. Teachers use screen time for less than 1 hour total per day, including active play yoga/dance, educational videos related to the curriculum/theme, and short age-appropriate viewing at transition time/end of the day.



- Q5: Room for Improvement: Curriculum: Smooth transitions between age groups, consistency, and progress documentation/tracking. Hired teacher with experience creating child learning/development portfolios. Working on them this summer and will begin in the fall.
- **Q6: Staff shoutouts!** Staff received Space Bucks Rewards that can be redeemed for snacks, gift cards, or PTO
- **Q7: Room for Improvement: Brightwheel:** Confusion on who is messaging: All staff assigned to the classroom have access to message in the app through the Parent/Teacher script. Only Admin, Karen Holt, Teresa Gill, Spring Aguirre, and Lena Batchelder have access to messaging through Parent/Admin script.
- **Q7: Room for Improvement: Brightwheel:** Working on teachers connecting with parents more on the app, without spending too much time with attention diverted from children.
- Q7: Room for Improvement: Comm Technology: PBJ challenging/laggy/choppy: PBJ made a major upgrade to their system and SFEI also upgraded our internet service. Major improvements.



- **Q8: Room for Improvement: Accuracy of Illness reporting:** SFEI began reporting illnesses during the Pandemic and has continued as it is helpful to parents to know what illnesses may be going around their child's classroom. We report what parents tell us.
- **Q8**: **Room for Improvement: Health and Safety:** Air Purification systems with HEPA filter cartridges were installed in all the classrooms in 2021. We continue to use them daily.
- **Q9: Feedback on Education Consultant Topics:** The SFEI Board asked parents what child development/behavior topics they would like to hear advice from expert Ann McKittrick on. Throughout the 23–24 school year, Ann joined our monthly staff meetings and spoke about: bedtime struggles, picky eaters, strong willed children, testing boundaries, technology, and parent leadership styles.
- **Q10: Other Feedback:** 2024 Graduation at the Gilruth was a success!
